The event's objectives were:


- > to introduce ECETOC to Chemical Users and Manufacturers, Chemical Federations and Academia in the new Member States;

## UPCOMING Workshops

### Association between Chemical Pollution and Respiratory Allergy and Asthma

(by invitation only)

Date: 16th - 17th June 2005

Place: Leuven, Belgium

In industrialised countries there has been an increase in the prevalence of asthma and of atopic disease. The increase has been too rapid to be caused by a change in the gene pool. Among the factors that have been implicated are the indoor environment, diet, vaccination programmes and the "hygiene hypothesis" (which suggests that decreased infectious challenge during infancy predisposes to atopic allergy).

The workshop will bring together scientific and clinical experts from industry, academia and government agencies, to consider specific questions regarding the apparent relationship between chemical pollution, asthma and allergic disease. A summary of the workshop will be published and key research needs identified.

### Symposium on Biomarkers and Molecular Epidemiology - Present state and future trends and Workshop on Environmental Genotoxins and Children's Health

Date: 5th July, 2005

Place: Kos island, Greece

The objective of this Symposium-Workshop, jointly organised by ECETOC and the European Environmental Mutagen Society (EEMS) is to: (i) review the state of the science in the fast developing area of biomarkers in identifying exposure to environmental stressors and subsequently in the field of molecular epidemiology, and (ii) address our current understanding of the role of genotoxic environmental agents in childhood disease (<http://www.eie.gr/eems2005/>). Papers presented will be published in Mutation Research.

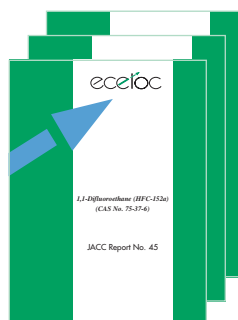
